#### COMMUNITY EVENTS

February 10, 2024 - KNZA, Inc VP of Operations Jake Spalding and KMZA staff member Heidi Wolfgang attended the Whine About Winter event in Seneca sponsored by the Seneca Area Chamber/Seneca Downtown Impact. Station programming information and information regarding careers, scholarships and internships was available.

March 11-12, 2024 -KNZA Program Director Seth Tollefson, owner Justin Fluke and on air staff conducted the annual Brown County Fair Spotlight Live Auction. Free on air coverage of three hours each night and staffing was provided for this fundraiser to support local 4H.

April 13<sup>th</sup>, 2024 - KNZA, Inc. hosted the 22<sup>nd</sup> Annual Regional Expo: Station owner Justin Fluke, Program Director Seth Tollefson and other radio station staff greeted people at the door and mingled throughout the crowd visiting with people, answering questions, and guiding them to pick up information on programming, careers, internships, and broadcasting scholarships at KNZA, Inc.'s table by the door.

April 28<sup>th</sup>, 2024 - KNZA, INC co sponsored the Troy Bridal Fair and served as emcee of the event as well as had a booth set up with information about our radio stations and broadcasting.

July through September 2024 - Various staff including owner/Program Director Seth Tollefson, VP Jake Spalding attended 11 area County Fairs and Interviewed 15+ 4-H fair participants from each local fair that aired during each week of each County Fair. Possible jobs and mentoring programs were discussed with many of these participants.

#### PARTICIPATION IN EVENTS SPONSORED BY EDUCATIONAL INSTITUTIONS

KLZA and KTNC Participated in the 2024 scholarship program of Nebraska Broadcasters Association. This included a commercial schedule promoting area students apply for these scholarships. KLZA and KTNC personnel Justin Fluke, owner and Heather Gill, Traffic Director, also participated in the judging of scholarship applications.

KNZA, KMZA, KOZA, and KAIR Participated in the 2024 scholarship program of the Kansas Association of Broadcasters. This participation was overseen by station owner and president Justin Fluke and included airing a commercial schedule encouraging students to apply. Each station aired 90 commercials from 2/1/24 to 4/30/24. Owner Fluke also participated in judging and interview selection process of the scholarships on May 20<sup>th</sup>, 2024 in Topeka, KS.

### PARTICIPATION IN EVENTS SPONSORED BY EDUCATIONAL INSTITUTIONS

<u>HS Student Workers =</u> January  $3^{rd}$ , 2024 through March  $15^{th}$ , 2024 and September  $1^{st}$  – December  $22^{nd}$ , 2024 our radio stations partnered with four local high schools (Sabetha, Holton, Hiawatha, Jackson Heights) and seven high school students on a paid internship program that they are receiving class credit for while helping us broadcast local games. Students have done weekly tasks for us and helped with on air, online and digital video sports productions. Student names include: Ethan Will, Zac Irey, Kryndon Proffitt, Kyson Proffitt, Zach Self, Paige Muller and Leah Kesler.

<u>College Internship</u> = Garin Noll, a student at Benedictine College in Atchison did an internship with KAIR Radio from August – December of 2024. Garin is pursuing a degree in broadcasting and learned all aspects of on-air and programming at the radio station. He was under the training and direction of Program Director Seth Tollefson, News Director Brian Hagen, and Sports Director Brandon Tadtman.

On September 18<sup>th</sup>, 2024, we had 10 students in a technology class from Everest Middle School come and your KNZA Radio station with Program Director Seth Tollefson. They also voiced promo's for the podcast which airs on our station every Saturday. Jobs in broadcasting as well as equipment and technology was discussed with these students who produce the radio podcast during the school year.

On November 12<sup>th</sup>, station owner/VP Jake Spalding attending the Jackson County <u>Career Fair</u> at Royal Valley High School and spoke with students between 9 AM and 12 PM about the broadcasting industry and jobs as well as how it effects their daily lives. Additionally discussed about podcasting and video streaming and the future of radio.

<u>Job Shadow =</u> On Tuesday, November 29<sup>th</sup>, Teagan Sharp, a senior from Horton High School, did a job shadow at KNZA main studio from 7:45-11:45 AM. She spent time with Program Director Seth Tollefson undestanding how radio works and our operation as well as other jobs at the station. Teagan also spent time with General Manager Wade Gerstner and Office Manager Cathy Nigus to experience and learn more about the broadcasting industry.

<u>Job Shadow</u> = On Monday, December  $16^{th}$ , 2024, Evan Sinclair, a senior at ACCHS visiting KNZA as a job shadow from 9AM-12PM. He is considering a career in media and marketing. Seth Tollefson discussed his role as program director and showed Evan the station before he also spent time with Office Manager Cathy Nigus and President Justin Fluke discussing sales and management.

On Friday, December 20<sup>th</sup>, 2024, Justin Fluke attended a <u>career fair</u> hosted by Sabetha Schools USD 113. For four hours, 8 groups of 15 of so students rotated through as Fluke talked about broadcasting and careers in radio as well as demonstrating some equipment and answering questions from students.

January 2025 – Ten students came to KAIR studio in Atchison, KS and recorded PSA's to air. Five students from Atchison's Trinity Lutheran School provided on air updates of Lutheran School Week activities and five students from Atchison's St. Benedict Catholic School provided on air updates of Catholic Schools Week activities both during the week of January 27<sup>th</sup>. News Director Brian Hagen toured, coached, and visited with the students about radio during their visit to station.
